

Privacy Policy

CFJ Foundation (“we,” “us,” “our”) is committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website at <https://cfj.foundation/> (“the Website”). By using the Website, you consent to the practices described in this policy.

1. Information We Collect

We may collect the following types of information:

- **Information you provide directly:** If you fill out forms, subscribe to newsletters, make a donation, volunteer, or contact us via the Website, we may collect your name, email address, any content in your message, and other information you choose to provide.
 - **Automatically collected information:** When you visit the Website, we may automatically collect information such as your IP address, browser type, operating system, device identifiers, pages you viewed, referring/exit pages, and timestamps.
 - **Cookies and similar technologies:** We may use cookies, pixel tags, web beacons, and similar technologies to collect usage data and to improve the Website’s functionality. You can control cookies through your browser settings (see “Your Choices” below).

2. How We Use Your Information

We may use your information for purposes such as:

- Providing, maintaining, and improving the Website.
- Responding to your inquiries or requests.
- Communicating with you about news, events, or volunteer/donation opportunities (only if you opt-in).
- Processing donations or transactions.

- Detecting, preventing, or responding to security incidents, fraud, or other malicious activity.
 - Complying with legal obligations.

3. Disclosure of Your Information

We may disclose your information:

- To service providers or vendors who perform functions on our behalf (e.g. payment processors, hosting services).
 - In response to legal process (e.g. subpoena, court order) when required by law.
 - To protect and defend our rights or property, or the safety of others.
 - In connection with a merger, acquisition, or sale of assets (if applicable).

4. Your Choices

- **Opt-out:** If you receive communications (e.g. email newsletter), you may opt-out of future communications by using unsubscribe links or contacting us.
 - **Cookies:** You can set your browser to refuse cookies or alert you when cookies are being sent. Deleting or disabling cookies may impact your ability to use some parts of the Website.
 - **Access / Correction:** You may request access to, correction of, or deletion of personal information you have provided (subject to legal exceptions).

5. Data Retention

We retain personal information only for as long as needed to fulfil the purposes outlined in this Privacy Policy, or as required by law. After that, we securely delete or anonymize the information.

6. Security

We implement reasonable security measures to protect information from unauthorized access, disclosure, alteration, or destruction. However, no method of transmission over the Internet or electronic storage is completely secure. Therefore, we cannot guarantee absolute security.

7. Children's Privacy

The Website is not intended for children under 13 years of age (or the minimum age required in your jurisdiction). We do not knowingly collect personal information from children under that age. If we learn we have collected such information, we will delete it as soon as reasonably possible.

8. Changes to this Privacy Policy

We may update this Privacy Policy from time to time. When we do, we will revise the "Last updated" date. Continued use of the Website after changes constitutes acceptance of the updated policy.
